ELDERS ULTIMATE GRAND FINAL WEEKEND PROMOTION 2025

TERMS AND CONDITIONS

- 1. The promoter is Elders Rural Services Australia Limited (ABN 72 004 045 121) (**Elders**) of Level 10, 80 Grenfell Street, Adelaide, SA, 5000.
- 2. Elders' Ultimate Grand Final Weekend Promotion (**Promotion**) commences at 9:00am Australian Central Standard Time (ACST) on Monday, 14 April 2025 and closes at 7:00pm ACST on Monday, 30 June 2025 (**Promotion Period**).
- 3. To be eligible to enter the Promotion, you must:
 - 3.1. be either:
 - 3.1.1. an individual residing in Australia over the age of 18 (including those in a trustee or executor capacity);
 - 3.1.2. a company incorporated in Australia that trades within Australia (including those in a trustee capacity);
 - 3.1.3. a domestic partnership;
 - 3.2. during the Promotion Period, open a new Elders' Rural Products Prepayment account with a minimum prepayment of \$10,000 with a Participating Entity as defined in clause 5 below; and
 - 3.3. accept and comply with these Terms and Conditions,

(referred to as an "Eligible Entrant").

- 4. There is no cost or fee to enter the Promotion. An Eligible Entrant may only enter the Promotion once.

- 6.2.2. Sydney for the NRL Grand Final departing Saturday 4 October 2025 and returning Monday 6 October 2025; and
- 6.3. accommodation for two (2) people for two (2) nights in the relevant host city at:
 - 6.3.1. Lanson Place Parliament Gardens in a Hotel Room King from Friday 26 September 2025 to Sunday 28 September 2025, if attending the AFL Grand Final; or
 - 6.3.2. Adina Apartment Hotel Sydney, Darling Harbour in a Studio King from Saturday 4 October 2025 to Monday 6 October 2025, if attending the NRL Grand Final.
- 7. The Prize is not transferrable or redeemable for cash or store credit.
- 8. Promotion draw process is as follows:
 - 8.1. Eligible Entrants are automatically entered into the Promotion;
 - 8.2. draw will be made via random selection using an electronic number generator from all Eligible Entries as recorded in Elders' records conducted by a representative of Elders at Level 10, 80 Grenfell Street, Adelaide SA 5000 at 12:00pm ACST on Tuesday, 15 July 2025;
 - 8.3. the winner will be notified by telephone and email within 7 days of the draw; and
 - 8.4. if after making reasonable attempts to contact or locate the winner, Elders is unable to do so by Monday, 18 August 2025 then that fact will be published in an appropriate forum and a redraw will be conducted at 12:00pm ACST on Tuesday, 19 August 2025 in the same manner at the same location and from the same pool of remaining eligible participants.

 - 9.3. if a winner is drawn from a Participating Entity that is not Elders, then additionally on the Facebook page of that Participating Entity on Wednesday, 16 July 2025.
- 10. For the purpose of clause 9, '**Details**' means the initial of the first name, last name and post code of the winner save for any winner who has requested their/its name and postcode to not be published.

 - 12.3.1. tampers with or benefits from any tampering with the entry process or with the operation of the Promotion;
 - 12.3.2. acts in a disruptive manner or with the intent or effect of annoying, abusing, threatening or harassing Elders, a Participating Entity or their respective officers, directors, employees, agents or contractors; or
 - 12.3.3. contravenes these Terms and Conditions.
- 13. Elders' decisions in relation to the Promotion, including in relation to eligibility to participate in this Promotion and the drawing process, are final.
- 14. Elders, a Participating Entity or any of their officers, employees, agents and contractors are not responsible for:
 - 14.1. lost, illegible, misdirected, incomplete or damaged entries; and
 - 14.2. incorrect or inaccurate transcription of information (including contact information), human error, technical malfunctions, lost or delayed entries.
- 15. By participating in this Promotion, each Eligible Entrant acknowledges, consents and agrees that Elders and the other Participating Entities may:
 - 15.1. collect and use personal information to conduct the Promotion including names and addresses;
 - 15.2. disclose personal information to its related bodies corporate, contractors and/or agents to assist it in conducting the Promotion; and
 - 15.3. disclose information to third parties to comply with trade promotion laws and regulations which may include publishing certain information detailed in these terms (see clause 9) if you are the winner or providing an Eligible Entrant's name to a regulatory body to comply with any record keeping or auditing requirements.

 - 19.1. participating in the Promotion;
 - 19.2. accepting, receiving, owning, insuring and using the Prize.
